

GENERAL TERMS AND CONDITIONS OF SALE

1) When placing an order, please enter the quotation number or the number of the last order.

2) The minimum price of the order is PLN 100 (or EUR 25) net (excluding the shipment costs). Orders below PLN 100 (or EUR 25) net are charged with an additional operating fee of PLN 20 (or EUR 5) net + VAT.

3) The orders which are shipped on pallets or half pallets for products worth below PLN 5000 are charged with the cost of packaging of PLN 100.

4) In order to meet the date of delivery, the Seller reserves the right to change the forwarding company if the shipment by the selected forwarding company is not possible due to the reasons beyond the control of the Seller.

5) The quotation does not mean the warehouse inventory becomes pre-ordered.

6) The quotation price is determined with the assumption of a one-time sell of the offered number in a declared delivery time. If the above are changed, the quotation is subject to separate arrangements.

7) For the purposes of issuing a sales invoice, the quotation price is converted to PLN in accordance with the sell exchange rate of the NATIONAL BANK OF POLAND – the first table from the date of issue of the invoice. At the Customer's request, an invoice in EUR can be issued.

8) The preliminary quotation is based on the details sent by the Customer (descriptions, photographs, designs, drawings etc.). Any changes or deviations arising from manufacturing capabilities of Maxbelt Janusz Rak S.K.A. are included in the quotation. All tolerances that have not been defined by the Customer are performed in accordance the ISO 2768-m standard. The dimensions that have not been defined (e.g. hubs, flanges, etc.) are performed in accordance with the Maxbelt catalogue. If necessary, a drawing is sent for acceptance. The completion date is counted from the date of acceptance of the drawing.

9) The completion time is counted from the date of placing the order (standard products available in the warehouse) or from the date of acceptance of the technical documentation by the Customer. In the case of a pro forma invoice, it is counted from the date of receipt of money on the account.

10) Validity of the quotation: the quotation is valid for 14 days or until the inventory is exhausted, or the lack of availability of the material out of which the inventory is made.

11) The quotation is valid in all its items with the exception of the date of delivery. The date of delivery is valid only if the order is placed on the date of the quotation. After this date, the quotation is subject to separate arrangements.

12) If an order is placed on the basis of the quotation, any discrepancies or changes must be marked in red in the order. All changes must be accepted by Maxbelt Janusz Rak S.K.A. in writing and it requires the amendment of the terms and conditions of the previous quotation.

13) Order cancellation. When the written confirmation of the order is received, the order cannot be cancelled.
